#### 1. What is the civic integration programme?

The civic integration programme helps you to find your way around in society.

The civic integration programme consists of the following programme components:

- 1. Social orientation (MO Maatschappelijke Oriëntatie)
- 2. Learning Dutch
- 3. Pathway towards employment
- 4. Participation and networking programme

Programme counselling is provided.

Your civic integration process will take [x] months. This may change. Your programme counsellor will discuss it with you and will confirm these changes in writing.

Have you successfully completed the civic integration programme? Then you will receive a civic integration certificate and the contract will end.

You are required to obtain the civic integration certificate.

You have obtained your civic integration certificate? You must also demonstrate that you have attained the Dutch B1 oral level no later than 24 months after the date of your civic integration certificate. Exemptions are possible: discuss it with your programme counsellor.

## 1.1 Social orientation (MO)

You do not have to register with VDAB.

In the MO course you will learn more about subjects such as work, housing, education and health. You will also learn more about values and standards and about your rights and obligations.  Your teacher will guide you so that you will learn to find the answers to all your questions yourself.  Your teacher speaks a language you understand.
Your MO course starts on [startdatumcursus]. At the end of the MO course, there will be an exam.
The start date of your MO course is not yet known. You will receive all information in good time through your programme counsellor. At the end of the MO course, there will be an exam.
You are exempt from MO. You do not have to attend an MO course.
1.2 Learning Dutch
You will be learning basic level Dutch.
· Your Dutch language course starts on [startdatumcursus]. At the end of the Dutch language course, there will be an exam.
The start date of your Dutch language course is not yet known. We will provide you in good time with all information. At the end of the Dutch language course, there will be an exam.
You learn Dutch through self-study and take a Dutch language certification test before [datum].
You are exempt from Dutch. You do not have to attend a Dutch language course.
1.3 Pathway towards a job

#### 1.4 Participation and networking programme

This programme will help you participate in activities in your new environment.

You will be meeting new people, and you can practice Dutch beyond the classroom walls. This can be done through volunteer work, buddying or other social activities.

You join a participation and networking programme. You make agreements with your programme
counsellor. You prove that you have attended for 40 hours.
You do not have to attend the participation and networking programme.

#### 1.5 Guidance

The programme counsellor will help you with your questions concerning the civic integration programme.

You will discuss the practical information and monitor your case with them: where and when to take courses, which exams to take etc

You will discuss your short-term and long-term plans with them.

#### 2. Agreements

#### 2.1 Civic integration certificate

To obtain the civic integration certificate, you must:

- 1. Achieve the social orientation (MO) goals
- 2. Achieve the Dutch language goals
- 3. Achieve the job pathway goals
- 4. Achieve the participation and networking programme goals

#### 2.2 Attendance

You attend the classes and exams.

You are unable to attend?

Always inform your programme counsellor. If you miss (part of) the class, it will be registered, even if you submit a supporting document for your absence.

Are you ill? Do you have other reasons not to attend?

Submit documentary evidence to your programme counsellor. They will collaborate with you to find a solution. You will attend the lessons or the exam at another time.

Are you working or taking a course?

Bring documentary evidence. Your programme counsellor will collaborate with you to find a solution.

#### 2.3 Costs

- You pay for the MO course and test. The payment agreements can be found in the MO fee regulations.
- You pay for the Dutch language course and test. Your school will give you information about the payment.
- The pathway to employment, the participation and network programme and the counselling are free of charge.

#### 2.4 Sanctions<sup>4</sup>

The civic integration programme is mandatory for you.

You do not respect the agreements? You may be penalised.

You were penalised? You are still obliged to obtain the civic integration certificate.

#### 2.5 Moving

Are you moving? Inform your programme counsellor of your new address.

You can continue the programme at your new location in Flanders or Brussels.

#### 2.6 Annexes

You are signing this contract? This means you agree to the content of the annexes to this contract.
