# FEE REGULATIONS

## SOCIAL ORIENTATION COURSE AND TESTS

In these regulations you will find the agreements on fees for the social orientation (MO) course and the MO<sup>1</sup> tests:

- The MO exemption test
- The MO course
- Post-course MO test

## 1 How much do the MO course and the MO test cost?<sup>2</sup>

You pay a fixed price.

- **90 euro for the MO exemption test**

The MO exemption test can only be taken once before signing the civic integration contract.

- **90 euro for the MO course**

Do you have to attend the MO course again? You do **not** have to pay again.

- **90 euro per MO post-course test**

Do you have to take the MO test again? Then you have to pay 90 euros **again**.

## 2 In which situations is no fee due?

- You are in one of these situations:
  - o You are registered in the national register at a municipality of the bilingual Brussels-Capital Region.
  - o You do not have a secondary education certificate **and** you are enrolled in one of these educational programmes:
    - Dutch language literacy modules and Learning to Learn
    - Organising one's own learning.
    - Basic education courses organised by Ligo.
    - General education or complementary general education courses
  - o You receive a *leefloon* (social integration income) or an income through welfare services **or** you depend on someone receiving a *leefloon* or an income through welfare services.
  - o You are detained<sup>3</sup>;
  - o You are a jobseeker, **and** you are taking a training course as part of a pathway towards employment<sup>4</sup>;
  - o You are a non-working, mandatory registered jobseeker **and** you are not yet entitled to an integration allowance at the time of registration;
  - o You are enrolled in a course at Ligo, Basic Education Centres (*Centra voor Basiseducatie - CBE*) . An adult education centre (CVO)<sup>5</sup> organises the course.
  - o You are younger than 18 or you will turn 18 in September, October, November or December<sup>6</sup>

- You already obtained a **civic integration certificate** from the German-speaking Community, the French Community, the French Community Commission, or the Common Community Commission:
  - o You do not have to pay for the MO exemption test.

## 3 When do you pay?

You pay when you enrol for the MO course and/or the MO test.

## 4 How can you pay?

You can pay digitally using a QR code or payment link.

You cannot make a digital payment? A staff member will inform you on how you can pay.

## 5 What if you have financial problems and cannot pay immediately?

Discuss the options with a staff member.

**You can be granted a deferred payment.**

- You agree on the terms of payment.

**You do not comply with the agreed payment terms? Then additional costs may be charged.**

- You will receive a registered letter. This letter is a payment reminder.

**Are you still not paying after receiving this payment reminder?**

- The Agency will transfer your case to the Flemish Tax Administration (VLABEL). This organization may decide to enforce the payment. This will incur additional costs. You will have to pay the extra costs yourself.

## 6 What if you refuse to pay?

- You refuse to pay at the start of the course or the test  
**And**
- You are **obliged** to attend the civic integration programme?

The Agency will forward your case to the enforcement officer. This person will decide on sanctions<sup>7</sup>.

- You may get a fine.
- You will still be obliged to pay.
- You will still be obliged to attend the programme.

Have you been granted a deferred payment due to financial problems? You will not be sanctioned.

## 7 When will you receive your civic integration certificate?

You will receive your civic integration certificate when:

- you have achieved all goals.
- you have paid the MO fees.
